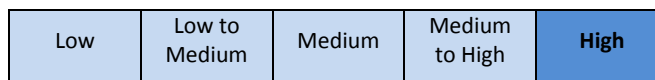

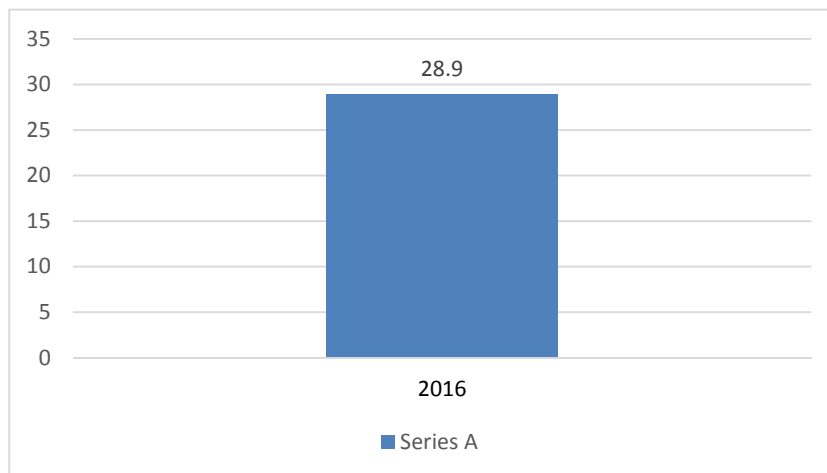

**AVERAGE RETURN**

The annual compound return of Series A shares of the fund was 14.10% since the inception of the fund. If you had invested \$1,000 in the fund at the inception of the fund, your investment would now be worth \$1,287.87.

**2. Fund expenses**

As of December 31, 2016, the fund's expenses were 5.06% of its value. This equals \$50.60 for every \$1,000 invested.

The performance fee will be 15% of the amount by which the net asset value ("NAV") of the Fund allocable to the shares of a series (the "Series NAV") at the end of the fiscal year (adding back the amounts of any distributions paid on the shares of the Fund) (the "ending NAV") exceeds the target NAV (the "target NAV"). The target NAV is calculated by multiplying the Series NAV, net of performance fees paid, as at the last performance fee payment date (the "beginning NAV") by the sum of one plus the return of the Fund's "benchmark" (the "benchmark return") over the same period.

The benchmark for the Fund is:

- S&P/TSX SmallCap Index (70%)
- Russell 2000 Index (30%)

### More about the trailing commission

The trailing commission is an ongoing commission. It is paid for as long as you own the fund. It is for the services and advice that your representative and their firm provide to you.

LDIC Inc. pays the trailing commission to your representative's firm. It is paid from the fund's management fee. The rate for this series of the fund is 1.25% of the value of your investment each year. This equals to \$12.50 each year for every \$1,000 invested.

### 3. Other fees

You may have to pay other fees when you buy, hold, sell or switch shares of the fund.

Fee	What you pay
Short-term trading fee	2% of the value of shares you sell or switch within 30 days of buying them. This fee goes to the fund.
Switch fee	Your representative may charge you up to 2% of the value of the shares you switch to another series of the fund.

### What if I change my mind?

Under securities law in some provinces, you have the right to:

- withdraw from an agreement to buy mutual fund shares within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

**1. Sales charges**

Series F1 shares are only available to investors whose representative has entered into an agreement with LDIC Inc. to make Series F1 shares available to clients of that representative. As a result, you pay no sales charge to buy Series F1 shares of the Fund.

**2. Fund expenses**

You don't pay these expenses directly. They affect you because they reduce the fund's returns.

As of December 31, 2016, the fund's expenses were 4.15% of its value. This equals \$41.50 for every \$1,000 invested.
